

Picturing the Los Angeles Jazz Scene

Sharon Benamou, Hermine Vermeij and Claudia Horning presented a poster session in San Diego on the Weber Jazz Collection. Mark Weber, a photographer, poet, and author, donated over 600 photographs to the UCLA Performing Arts Special Collections. This collection of photographs, taken mostly by Weber, documents experimental jazz musicians and musical groups during the 1970s-1990s (the majority were taken in Los Angeles between 1976 and 1985). The photographs were digitized by the UCLA Digital Library Program and metadata for them created by the Metadata Taskforce within the Cataloging & Metadata Center. The photographs also document well-known music venues, such as the Hollywood Bowl, music festivals (e.g. the Playboy Jazz Festival), and small venues which may no

longer exist. The metadata includes extensive indexing of musicians, venues and musical instruments. Geo-tagging coordinates are supplied when exact locations are known. The poster demonstrated how the geo-tags may be used in the future by linking to images associated with the coordinates. This provoked great interest in others working on digital projects. Public Libraries Committee Update



Music Library Association Annual Meeting

March 21-24, 2010 San Diego, CA

A Celebration of Jazz at Brand Library

Alyssa Resnick and Blair Whittington of Brand Library presented a poster session on March 23 at the Music Library Association (MLA) annual meeting in San Diego, CA. The 4'x6' poster captured many images from ***A Celebration of Jazz at Brand Library***. These events paid tribute to the vibrant Los Angeles area jazz scene in pictures, sound, and words. Two weeks of programming included seven events: concerts, film screenings, and talks with musicians and artists, organized around ***The Performance Portraits of Bob Barry***, an exhibition of the Los Angeles based photographer's remarkable award-winning images.

The events were organized by Cathy Billings (Art Librarian/Gallery Manager), Blair Whittington (Music Librarian/Recital Hall Manager), Alyssa Resnick (Senior Library Supervisor/Gallery & Recital Hall Director) and photographer Bob Barry. The Brand Library staff worked with Bob Barry to schedule the performing artists and the musicians and artists who participated in the talks or panel discussions. All events were free and open to the public and co-sponsored by the Associates of Brand Library.

MLA members who visited the poster were impressed with the poster itself but also impressed with the professional events that the staff were able to bring to the public. In addition to the poster that was made the booth also included a banner from the event, postcards, laminated flyers and a photo album of 150 photographs that further documented the event. The most asked question from visitors was how so many events could be funded and produced by such a small staff. The exhibition was part of Brand Library Art Galleries annual gallery schedule, the performing artists were compensated with funds from the Associates of Brand Library, speakers donated their time, rights to screen the films were provided at no charge, and printed materials were funded through the gallery's annual graphic budget and a printer with extremely inexpensive prices was used. It was a great experience to show the members of MLA, who are primarily from academic institutions, these extraordinary events that were produced at a public library at no charge to the guests who attended.

MLA/SCC - AMS Pacific Joint Meeting

February 12, 2010, CSU-Long Beach Long Beach, CA

Presentation Highlights by Lindsay Hansen and Lisa Nitsch

Seth Houston, a doctoral student at USC, gave the first presentation of the day, "Restoring Self Through an Exotic Other: Orientalism and the Poetic in Robert Schumann's *Das Paradies und die Peri*." He argued that Schumann employed a few key motifs in this lesser-known work and explained that *Paradies* represented Germany's attempts to surpass Greece as the center of cultural importance. Houston also noted that given the fascination with Orientalism at the time, Schumann did not use many non-Western motifs.

Catherine Brown, a librarian at UCLA's Biomedical Library, spoke about Powell Library's successful concert series in "Music in a Library!? The UCLA Powell Library as a Non-Traditional Performance Space." She provided a literature review of library concerts dating back to the early 20th century (Boston Public, Los Angeles Public, etc.) and described the many challenges of library concerts: balancing the library patrons with concertgoers, having a barebones budget and requiring free performances, and the acoustics. She shared a short video of UCLA Music Library employee Henry Lim, who recently performed Bob Dylan songs with a string quartet. The concert series at Powell Library originated in the early 1960s, ending in 1990 and rejuvenated in 1998. The music performed is primarily early, including vocal, classical guitar and strings, but musicians have also played contemporary pieces. Stephen Penner, a graduate student in conducting at California State University, Northridge, presented his findings on "Hype in Classical Music-Good or Bad?" Mentioning that the Los Angeles Philharmonic had earmarked \$750,000 to promote the arrival of new conductor Gustavo Dudamel, Penner had set out to determine if, historically, this kind of promotion was beneficial. He consulted the archives of the LA Times, LA Philharmonic, and the City of Los Angeles, counting the number of articles preceding the arrival of conductors such as Andre Previn and Esa-Pekka Salonen. He also compared the number of orchestral recordings per conductor, as one measure of the orchestra's success, having been unable to acquire data on ticket or subscription sales. He concluded that "hype has not been a factor in the orchestra's success or value."

Dr. Alejandro Planchart of UC-Santa Barbara provided an enlightening presentation, "The Nature of the Prose Repertory in Southern Italy," noting how the influence of Roman Gregorian Chant can be found in the troupes, proses, and sequentiae of the early ninth century in Southern Italy. Dr. Planchart noted that this influence could best be attributed the music brought by the armies of Charlemagne, during the Crusades. His presentation also examined how in the ninth century, and throughout the tenth and eleventh centuries, local cantors of Southern Italy composed sequentiae, proses, and tropes for local, as well as major feasts of the year, developing unique works which combined and exhibited aspects of the local Beneventan musical style, as well as Gregorian and Frankish musical influence.

The joint meeting concluded with an entertaining presentation by Dr. Roger Hickman, Professor of Music History at California State University, Long Beach. In his presentation, "Miklós Rózsa's March Madness," Dr. Hickman's noted that the Hollywood film composer Miklós Rózsa demonstrated a significant use of the march genre in a number of his 100 film scores. Perhaps the most notable examples are exhibited in his Oscar winning film score "Ben Hur." Dr. Hickman provided examples exhibiting the composer's musical development throughout his career and his use of the march to underscore a wide range of emotions, from triumph to tragedy, with the use of the recognizable military march style, funeral marches, as well as creating a sense of suspense in the composer's well known Film Noir scores. Dr. Hickman concluded that perhaps the composer's unprecedented fondness for marches may have been influenced by the marches found in Arthur Honegger's score to "Les Miserables."
